





## THE HOUSE



THE LOCATION



### PLANNING CONTEXT

An existing planning permission has been lawfully implemented and certified by Runneymede Borough council for the development of ten houses with a combined floor area of 2,126m<sup>2</sup> with the total volume being 6,627m<sup>3</sup>. The permission benefits from a private access via a new junction with Stroude Road.

Adam Architecture have prepared an indicative scheme for a single country house that would be looked upon favourably.
